

5 Key Factors That Determine California Spousal Support

1. The Income and Earning Capacity of Each Party

The most obvious factor is how much money everyone makes. The court looks at gross income from all sources, including wages, commissions, royalties, and investment income. Beyond current income, they look at earning capacity. If a spouse has a degree or a history of high earnings but is currently underemployed, the court may calculate support based on what they could be earning. This prevents parties from quitting their jobs just to avoid paying or to increase their receipt of support.

2. The Standard of Living Established During the Marriage

The court aims to allow the supported party to live at a standard close to what they enjoyed during the marriage, provided the paying spouse can afford it. This involves analyzing spending habits, the type of home lived in, the cars driven, and the vacations taken. Proving the standard of living requires detailed financial records. It is often a point of contention, with one side claiming a frugal lifestyle and the other claiming a lavish one.

3. The Duration of the Marriage

The length of the marriage is the primary driver for how long support will last. In California, a marriage of under 10 years is generally considered short-term, and support is typically ordered for half the length of the marriage. A marriage of over 10 years is considered long-term. In these cases, the court does not set a definite end date for support, retaining jurisdiction to modify the order later. This distinction is critical for long-term financial planning.

4. The Supported Party's Contribution to the Other's Career

Did one spouse work to put the other through medical school? Did one spouse stay home to raise children, allowing the other to focus entirely on building a high-earning career? The law recognizes these non-monetary contributions. If your sacrifices helped your spouse increase their earning power, the court weighs this heavily in your favor when determining support awards.

5. Age and Health of the Parties

The physical and mental health of both spouses plays a role. A spouse who is older or suffers from a disability may require support for a longer period because their ability to become self-sufficient is lower.
